## **Brief Introductions**

### **to the Specially Invited Speakers and Discussants**

#### **Keynote Speakers:**

##### **Eric Hanushek**

Eric Hanushek is the Paul and Jean Hanna Senior Fellow at the Hoover Institution of Stanford University. He is internationally recognized for his economic analysis of educational issues, and he received the Yidan Prize for Education Research in 2021. His research has had broad influence on education policy in both developed and developing countries. He is the author of numerous widely-cited studies on the effects of class size reduction, school accountability, teacher effectiveness, and other topics. He was the first to research teacher effectiveness by measuring students' learning gains, which forms the conceptual basis for using value-added measures to evaluate teachers and schools, now a widely adopted practice. His recent book, *The Knowledge Capital of Nations: Education and the Economics of Growth* summarizes his research establishing the close links between countries' long-term rates of economic growth and the skill levels of their populations. He has authored or edited twenty-four books along with over 250 articles. He is a Distinguished Graduate of the United States Air Force Academy and completed his Ph.D. in economics at the Massachusetts Institute of Technology.

#### **Specially-Invited Discussants:**

##### **Steven Lehrer**

Steven Lehrer is a Professor of Economics, Queen's University and a research associate at the National Bureau of Economic Research. His work has appeared in the Review of Economics and Statistics, Review of Economic Studies, Nature, American Political Science Review among other outlets. He also serves as the Chief Economist for Janys Analytics a company which develops social media products for financial applications including the Wall Street Journal-IHS Markit U.S. Sentiment Index. His



recent research evaluating universal childcare policies was awarded the 2013 John Vandekamp prize for best article in Canadian Public Policy and his work on genetic lotteries received the 2009 Victor R. Fuchs Research Award for his best paper with the potential to spawn new research in an underdeveloped area of health economics or health policy. In 2015, he was invited to join the Shanghai Thousand Talent for Foreign Experts program.

### **Fangwen Lu**

Fangwen Lu is a professor at Renmin University of China, who obtained a PhD degree from UC Berkeley in 2011. She excels in using random field experiment to explore challenges in development/labor economics. Lu has published in leading international journals, such as *British Medical Journal*, *Management Science*, *Journal of Development Economics*, *Journal of Labor Economics*, *Journal of Public Economics*, *Journal of Economic Behavior & Organization*, *Journal of Environmental Economics and Management*, etc.

## **BRIEF INTRODUCTION TO CHINA'S HUMAN CAPITAL PROJECT**

### **1. China's Human Capital: Measurement and Index**

The research project, “China's Human Capital: Measurement and Index Construction,” is conducted by the China Center for Human Capital and Labor Research Center (CHLR) and funded by the National Natural Science Foundation of China and the Central University of Finance and Economics (CUFE). The project is establishing China's first scientific and systematic human capital index and quantitatively describing China's human capital distribution, trend and dynamics. It constructs important measures for further evaluating human capital and its contribution to economic development and provides policymakers with important information on the nation's human capital development.

The project is part of the international effort to establish comparable national human capital measurement across nations and to eventually incorporate human capital into the National Income and Product Accounts (NIPA) system.

The project is led by Professor Haizheng Li. The research team includes Professor Barbara Fraumeni (a pioneer scholar in developing the Jorgenson-Fraumeni method of human capital calculation), other full-time and special-term professors, graduate students, and the administrative staff at the CHLR.

Since the inaugural issue of the China Human Capital Report in 2009, the project has generated great social impact, and it has drawn the attention of academia and governments both at home and abroad.

#### **Funding:**

- The project was initiated in 2009 and has been funded by various priority research funds from the CUFE. The project has been designated as one of the representative research projects at the CUFE.
- The project has continuously been funded by the National Natural Science Foundation over the past ten years.

#### **Team:**

- The project has been conducted in cooperation with universities in the United States, including Georgia Institute of Technology, Ohio State University, and State University of New York at Buffalo.
- The research team includes the two founders of the Jorgenson-Fraumeni income-based approach: Professor Dale Jorgenson at the Harvard University and Professor Barbara Fraumeni, who also serves as a special-term professor in the Center.

- The team includes all full-time and special-term professors, graduate students, and the administrative staff at the CHLR.

### **China Human Capital Report (in both Chinese and English version):**

- The China Human Capital Report series has been released every year since 2009 in an international conference on human capital hosted by the CHLR. Keynote speakers and conference participants have included:
  - The Nobel Laureate late Professor Kenneth J. Arrow, Professor Dale Jorgenson, and scholars from the World Bank, the OECD and many other institutes around the world;
  - Professor Zhenghua Jiang, the Vice Chairman of the National People's Congress, Keng He, the Vice Chairman at the Finance and Economics Committee of the Standing Committee of the National People's Congress, Guoqiang Long, the Vice Director at the Development Research Center of the State Council, Xianchun Xu, the Deputy Director at the National Bureau of Statistics, and many other scholars all around China.

### **Impacts in China:**

- The annual release of the China Human Capital Report has normally been covered in major media in China, such as Guangming Daily, People's Daily Online, Sina Online, and Jiefang Daily.
- The annual China Human Capital Report is regularly submitted to the Ministry of Education and the Department of Organization for policy reference.
- The CHLR has established formal collaboration with several research institutes such as the Beijing Human Research Center of Beijing Municipal Department of Organization.
- The project was noted favorably by Yandong Liu, the current Vice Premier of the State Council (and then State Consular), during her visit of the university in 2009.

### **Academic impacts:**

- The Human Capital Report has been included in the World Bank Report, "The Changing Wealth of Nations."
- Parts of the China Human Capital Report have been published as working papers of the National Bureau of Economic Research (NBER).
- Parts of the China Human Capital Report have been published as research papers in peer-reviewed journals, including *Journal of Comparative Economics*, *Review of Income and Wealth*, *China Economics Review*, and *Economic Research Journal* (the top Chinese journal in economics).
- The project team has been invited to many domestic and international conferences, including presentation at the plenary session of the Fifth World KLEMS Conference at Harvard University and the keynote address at the Society of Economic Measurement Annual Conference in 2018.

### **Impacts worldwide:**

- The China Human Capital Project is part of the international effort in establishing comparable human capital measurement across nations. The innovative methods used in the project have been increasingly recognized and adapted worldwide.
- Professor Dale Jorgenson has included a major reference and citation to the Report in his comment on the China Human Capital measurement project in his review paper published in the *Journal of Economic Literature* (2018).
- The project team has been invited to join the large research project on human capital sponsored by the European Union, LLLight'in'Europe FP7 (SSH-2011-2).
- The CHLR has been invited by the International Association for Research in Income and Wealth (IARIW) to jointly host the 2021 special conference on human capital.

## **2. International Symposium on Human Capital and Labor Markets**

In the release of the China Human Capital Report, the CHLR holds an annual international conference on human capital. The conference receives over a hundred submissions each year, and it has become an influential conference in the area of human capital research.

## **3. Human Capital Database**

The human capital measurements produced by this project have been widely used in research and policy analysis. The database on China human capital measures and all processed data and raw data, mostly longitudinal, are freely available to the public at:

## **4. Educational Impact**

### 1. 中国人力资本度量研究项目

人力资本与劳动经济研究中心（以下简称“中心”）的“中国人力资本的度量及人力资本指标体系的构建”项目得到国家自然科学基金委员会及中央财经大学的专项资助。该项目旨在建立中国第一套科学、系统的人力资本指数，定量描述中国人力资本的分布及发展动态；为更深入地研究人力资本在中国经济发展中的作用提供综合的度量指标；为政府的相关经济社会决策提供定量依据；同时也为中国的人力资本度量方法和指标成为国际人力资本指标体系的一部分、为人力资本作为国民账户的一部分纳入到我国国民财富的衡量体系提供前期工作。该项目由李海峥教授主持，人力资本收入算法（Jorgenson-Fraumeni 方法）创始人之一的 Barbara Fraumeni 教授直接参与项目，中心全职教授和特聘教授，以及全体博士、硕士研究生及行政人员共同参与。

经过十余年连续努力，中心建立了中国第一套科学的、国际化的、连续更新的人力资本度量体系。《中国人力资本报告》自 2009 年公开发布以来，受到了国际、国内学术界及政府部门的高度重视，引起了广泛的、良好的社会反响。

## **CHINA CENTER FOR HUMAN CAPITAL AND LABOR MARKET RESEARCH**

Established in March 2008, the China Center for Human Capital and Labor Market Research (CHLR) at the Central University of Finance and Economics (CUFE) is part of a Special Platform for Advance Programs at the CUFE. It is an international research center for the study of human resources, labor markets, and their impact, focusing on China and related economies.

Nobel Laureates James Heckman, and Professor Dale W. Jorgenson of the Harvard University and the founder of the income-based method for measuring human capital, serve on the Advisory Board.

All faculty and research fellows of the CHLR hold a Ph.D. degree in economics from major universities in North America and Europe, and all visiting professors are tenured professors from major U.S. universities. Currently the Center has 8 full-time faculty members, 8 special term professors, and 10 senior research fellows. Among the teachers, there are 7 special term professors 2 associate professor and 6 assistant professors.

The major research areas in the Center include but are not limited to human capital investment; its measurement and impact; education, health; innovation, entrepreneurship; and labor market outcomes and labor-related government policy.

The CHLR has master's, doctoral and post-doctoral programs. The Center's graduate programs are internationally oriented. The curriculum and instruction are rigorously designed following research universities in North America. All courses are taught in English.

## 中央财经大学

### 人力资本与劳动经济研究中心简介

人力资本与劳动经济研究中心（CHLR）（以下简称“中心”）隶属于中央财经大学“经济学与公共政策优势学科创新平台”，成立于 2008 年 3 月，是一个以研究中国人力资本、劳动力市场及其与经济发展关系为主要研究方向的院级国际化研究中心；中心招收博士后、博士和硕士研究生。中心顾问由该领域的国际著名教授担任，其中包括诺贝尔经济学奖得主 James Heckman 教授，以及人力资本计算方法——终身收入法创始人之一，哈佛大学的 Dale W. Jorgenson 教授。

中心的教学科研成员全部为北美知名高校的终身教授或者拥有北美或欧洲知名高校经济学博士学位的海归学者。中心有全职教师 8 人，特聘教授 8 人及特聘研究员 10 人。教师队伍中，特聘教授 7 人，副教授 2 人，助理教授 6 人。

中心以科研为主导，强调国际化的前沿学术研究。主要研究方向为：1）人力资本的形成、度量及作用，2）教育、健康与人力资本，3）人力资本与创新及创业，4）劳动力市场与政策，5）人口与社会保障，6）产业组织。

中心拥有科学完备的博士及硕士研究生培养方案，其课程体系和课程设置与美国研究类高校一致，采用全英文授课及国际化人才培养方式。截至 2021 年 10 月，中心已毕业博士后 1 人，博士生 10 人，硕士生 128 人。目前在校生 52 人，其中全日制硕士生 43 人，全日制博士生 9 人。

Central University of Finance and Economics & University of Electronic Science and Technology of China Joint Research Data Center (hereafter referred as “CEDC”) was established in April 2018. It was jointly founded by the Central University of Finance and Economics and the University of Electronic Science and Technology. The establishment of CEDC fully combines the advantages of the Central University of Finance and Economics in the field of Finance and economics and the technological advantages of the University of Electronic Science and Technology. It is a formal academic research institution affiliated to the Scientific Research Department of Central University of Finance and Economics. Currently we have 1 director, 2 vice directors, 11 advisors, 6 fellows, 2 full-time administrative members and 3 student assistants.

CEDC aims to establish a data-sharing platform for research and policy use. It provides fund to build databases from various research projects, to support data collections and offers a user-friendly web space for searching and downloading data.

As of now, CEDC has sponsored eight data projects, including two unique large databases, the China Human Capital Database and the China Fiscal Statistics and Information Database. We are now working with the National Health Commission (Migrant Population Service Center) to share their large-scale migration data, and with Peking University on the Enterprise Survey for Innovation and Entrepreneurship in China (ESICE).

In the long term, the CEDC plans to create its own unique data in addition to supporting data sharing from other projects. Additionally, CEDC hosts annual conference on data science.

从长远来看，CEDC 除了支持其他项目的数据共享外，还计划建设自己的数据。计划在未来与经济合作与发展组织（OECD）建立合作，在整合国内数据的同时，引入 PIAAC 及多项国际数据库，完成数据本土化处理工作，实现 CEDC 的国际化。

## **JINAN HUMAN CAPITAL INDUSTRY RESEARCH INSTITUTE**

Jinan Human Capital Industry Research Institute is committed to exploring the application of human capital, adheres to the integrated development of talents, capital and projects, builds a "people-oriented" human capital industry ecology, and promotes the development of the human-capital-related industry with Chinese characteristics.

Talent Price (Shandong) Co., Ltd is responsible for the marketing and commercialization of scientific and research findings of the institute. With support from national, provincial, municipal, and district governments, China's first human capital industrial park has been built in Jinan and the first human capital evaluation platform has been launched. These jointly make "human-capital-related services" listed in the "The Catalogue of National Industrial Structure Adjustment (2019)". The institute's human capital research contributes to the innovation of financial models, and these innovated models are included as pilot projects initiated by six national ministries and commissions. The personal loan project is listed as the People's Bank of China regulatory sandbox project.

Based on talent evaluation and pricing, the institute focuses on integrating human capital research with the innovation of financial models. Using the evaluation and pricing system based on the "four CAIs" jointly built with the Central University of Finance and Economics and China Center for Human Capital and Labor Market Research, the institute has completed more than 200,000 evaluations and issued more than 30,000 credits. ### **2009--The First International Symposium on Human Capital and Labor Markets**

#### *About the Symposium*

On October 10, 2009, CHLR held its first international symposium on measurement of human capital and released the China Human Capital Report 2009. The Principle Investigator for the project, Prof. Haizheng Li presented the methodology of the estimation of human capital stock and the estimation results at the national level for 1985-2007. The China Human Capital Report 2009 establishes China's first systematic and comprehensive human capital measurement and human capital index, including the stock of human capital of China 1985-2007, by urban-rural and by gender; human capital per capita; various human capital indices; and the forecast of China's human capital stock for 2008-2020. The symposium included academic sessions focusing on the measurement of human capital, construction of the human capital index, and the contributions of human capital to economic growth and welfare.

#### *Participants*

Nobel Laureate Prof. Kenneth J. Arrow, Nobel Laureate Prof. James Heckman, Prof. Ken He (Deputy Director, Finance Committee of the Standing Committee of the National People's Congress), and Prof. Dale W. Jorgenson (co-founder of the Jorgenson-Fraumeni income-based method for measuring human capital, Harvard University), gave keynote speeches in the plenary session. Prof. Guangqian Wang (President of CUF), Prof. Donggang Zhang (Deputy Director of the Social Science Division, Ministry of Education), Dr. Xianchun Xu (Deputy Commissioner, National Statistics Bureau), and Dr. Zhongjie Jia (Director of the Senior Civil Servants Training Center, Ministry of Human Resources and Social Security) also participated in the symposium. Over 800 domestic and foreign scholars including Professor Barbara M. Fraumeni (University of Southern Maine), national and international government officials, as well as university students, attended the symposium.

### **2010--The Second International Symposium on Human Capital and Labor Markets**

#### *About the Symposium*

The Second International Symposium on Human Capital and Labor Markets and the release of the China Human Capital Report 2010 was held in Beijing October 15, 2010. The symposium was organized by the CHLR. In the meeting, the China Human Capital Index and Report 2010 were released. This year's report updates the human capital estimation at the national level; and for the first time, human capital at the provincial level is estimated. The 2010 report includes human capital estimation results for Beijing, Liaoning, Jiangsu, Guangdong, and Gansu.

#### *Participants*

Dr. Ardo Hansson (Chief Economist, World Bank China Office), Dr. Danling Zhao (Official of Ministry of Education), Prof. Yuetian Li (Deputy Director-General of Ministry of Human Resources and Social Security), and Prof. Guoqiang Long (Director-General, Research Department of Foreign Economic Relations, the State Council Research and Development Center) provided helpful comments on the human capital index report, as specially invited discussants. Prof. Barbara Fraumeni (a co-developer of the Jorgenson-Fraumeni method of human capital calculation) chaired the meeting, and Professor Haizheng Li presented new results

from the Human Capital Report 2010. Additionally, officials from the Ministry of Education, National Development and Reform Commission, the National Bureau of Statistics, the Department of Organization of Beijing, and the Development and Reform Commission of Shanghai, and other agencies, as well as domestic and foreign scholars attended the symposium.

## **2011--The Third International Symposium on Human Capital and Labor Markets**

### *About the Symposium*

The Third International Symposium on Human Capital and Labor Markets and the release of the China Human Capital Report 2011 was held in the Central University of Finance and Economics (CUFE) on October 28, 2011. The symposium was organized by the CHLR, and it released the China Human Capital Report 2011. Compared with previous human capital reports, the 2011 Report shows significant improvements in calculation methods, addresses the problem of missing data at the provincial level, and also adds new micro survey data. The Report updates the national human capital estimates for 1985-2009 and expands the coverage to 12 provinces (Beijing, Shanghai, Gansu, Guangdong, Jiangsu, Liaoning, Anhui, Shandong, Guizhou, Hubei, Hunan, and Henan). In addition, the Report discusses human capital across provinces and their trends and patterns.

### *Participants*

Specially invited discussants and commentators, Desheng Lai (Dean, Beijing Normal University), Yang Du (Fellow, Institute of Labor and Population Economics, Chinese Academy of Social Sciences), Zhaoming Gui (Professor, Wuhan Institute of Technology), Yongzhi Liu (Director, China Association of International Exchange of Personnel), Philip O'Keefe (Lead Economist, World Bank) gave in-depth discussions on this year's Report. Mr. Fengyun Lei (Deputy Director, State Administration of Foreign Experts Affairs), Prof. Barbara Fraumeni (a co-developer of the Jorgenson-Fraumeni method of human capital calculation), Prof. Yijun Li (Deputy Director, Division of Management Science, National Natural Science Foundation of China), Junsheng Li (Vice President, Central University of Finance and Economics), as well as other domestic and foreign scholars also attended the symposium.

## **2012--The Fourth International Symposium on Human Capital and Labor Markets**

### *About the symposium*

The Fourth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2012, organized by the CHLR was held in CUFE on December 14, 2012. The China human capital report 2012 was released. The new report uses updated provincial statistical data and computes human capital for five new provinces (Tianjin, Heilongjiang, Zhejiang, Guangxi and Shaanxi) in 1985-2009. The corresponding panel data of measures of human capital for 17 provinces was constructed. Various data of human capital were released online at the Center's website to promote sharing of research data.

### *Participants*

Prof. Barbara Fraumeni (University of Southern Maine, a co-developer of the Jorgenson-Fraumeni method of human capital calculation) chaired the plenary session. The new human capital report was presented by Prof. Haizheng Li. As specially invited discussants and commentators, Prof. Weiping Li (the chief research fellow from the Chinese Academy of Personnel Science), Prof. Dennis Tao Yang (University of Virginia), and Prof. Yansui Yang (Tsinghua University), gave insightful comments on the Report. In the afternoon, the conference organized three academic sessions. Scholars from China and other countries discussed ongoing research related to broad issues of human capital and labor markets. Prof. Rachel Connelly

(Bowdoin College), Prof. Zhenhui Xu (Georgia University and College), and Prof. Dennis Tao Yang chaired the academic sessions. Prof. Lifan Zhao (Vice President of CUFE) also attended the symposium.

### **2013--The Fifth International Symposium on Human Capital and Labor Markets**

#### *About the symposium*

The Fifth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2013, organized by the CHLR was held in CUFE on December 15, 2013. The China human capital report 2013 was released. Updated national and provincial human capital used newly released 2010 census data. Estimated human capital for 5 new provinces in 1985-2010: Hainan, Jiangxi, Jilin, Sichuan, Chongqing. The corresponding panel data of gross measures of human capital for 22 provinces was constructed. The Report also contained estimates of the national and provincial physical capital stock and cross-provincial living cost.

There were 10 human capital-related parallel academic sessions in which there were 41 research papers selected from international and domestic submissions. Scholars from China and other countries discussed ongoing research related to broad issues of human capital and labor markets.

#### *Participants*

Prof. Barbara Fraumeni (University of Southern Maine, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) chaired the plenary session. The new human capital report was presented by Prof. Haizheng Li. As special invited keynote speakers, Prof. Zhenghua Jiang (former vice chairman of the National People's Congress) and Prof. Mark R. Rosenzweig (Frank Altschul Professor of Economics, Yale University) gave keynote speeches. Dr. Vincent Perrin (OECD Beijing Representative), Prof. Belton M. Fleisher (Editor of China Economic Review & Ohio State University & CHLR), Prof. Guangqian Wang (president, CUFE), Prof. Junsheng Li (Vice President of CUFE), and Prof. Lifan Zhao (Vice President of CUFE) also attended the symposium.

### **2014--The Sixth International Symposium on Human Capital and Labor Markets**

#### *About the symposium*

The sixth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2014, organized by the CHLR, was held in CUFE on October 31, 2014. The China human capital report 2014 was released. The Report included estimated human capital for 9 new provinces in 1985-2010: Shanxi, Qinghai, Inner Mongolia, Xinjiang, Tibet, Yunnan, Fujian, Hebei, Ningxia, Hong Kong and Taiwan; re-estimated human capital for Hainan province; estimated and national and provincial physical capital stock; and estimated cross-provincial living cost indices.

#### *Participants*

Jeffrey S. Zax (Professor, University of Colorado at Boulder) chaired the plenary session. Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, China Economic Review) gave a speech on "Remarks in Memory of Gary S. Becker." The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) and Carsten A. Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators included Shujie Han (Editorial Director, Journal of Human Resource

Development of China), Martina Lubyova (Director, Institute for Forecasting, Slovak Academy of Sciences), Peter F. Orazem (Professor, Iowa State University) and Jeffrey S. Zax (Professor, University of Colorado at Boulder), who gave in-depth discussions on this year's Report. Prof. Junsheng Li (Vice President of CUFE) also attended.

We received 77 submissions, among which 32 were accepted for presentation.

## **2015--The Seventh International Symposium on Human Capital and Labor Markets**

### *About the symposium*

The seventh International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2015, organized by the CHLR was held in CUFE on December 12, 2015. The China human capital report 2015 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) were extended to 1985-2012. There were some revisions and improvements in the 2015 Report, including updating the data for enrollment categorized by region and gender to 1985-2012, and adding China Family Panel Studies (CFPS2011) to estimate Mincer parameters. The China Human Capital Report 2015 also reported the average age of labor force, average education level and the proportion of population with high-school education. The news of establishing CPS (Complex Problem Solving) Test Lab in China by the CHLR was released during the symposium.

### *Participants*

Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, China Economic Review) chaired the plenary session. The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) and Carsten A Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators: Gary Jefferson (Professor, Brandeis University), Scott D. Rozelle (Professor, Stanford University), Shi Li (Professor, Beijing Normal University) and Tao Xin (Professor, Beijing Normal University). Phil. Samuel Greiff (Associate Professor, University of Luxembourg), Kevin Murphy (Professor, Colorado State University) and Peer Ederer (Professor, Zeppelin University) participated in the releasing the news of establishing CPS (Complex Problem Solving). Jianfeng Peng (Professor, Renmin University & Chairman, China Stone) and Jianping Shi (Vice President of CUFE) also attended.

More than one hundred of international and domestic scholars attended the seventh human capital symposium. The symposium selected 40 papers out of 98 submissions, with 10 parallel sessions covering education, income, health, poverty and behavior, labor market, employment, immigration, human capital, children and complex skills.

## **2016--The Eighth International Symposium on Human Capital and Labor Markets**

### *About the symposium*

The eighth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2016, organized by the CHLR was held in CUFE on December 10, 2016. The China human capital report 2016 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) has been extended to 1985-2014. There were some revisions and improvements in the 2016 Report, including updating the data on school enrollment by region and gender based on new data sources for 1985-2014, and estimating both national and provincial physical capital stock for 1985-. The China Human Capital Report 2016 also unified the

population estimation method at the national and province level, and it included data on re-calculated national human capital.

The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) and Carsten A. Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators, Min Tang (Ph. D, State Department Counselor & Vice President of YouChange China Social Entrepreneur Foundation), Boqing Wang (Ph. D, Founder & Chair of MyCOS (China Occupational Skills)) gave in-depth discussions on this year's Report. Jianping Shi (Vice President of CUFU) also attended.

We received 122 submissions, among which 60 papers were accepted for presentation in 14 parallel sessions.

### **2017--The Ninth International Symposium on Human Capital and Labor Markets**

#### *About the symposium*

The ninth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2017, organized by the CHLR was held in CUFU on December 9, 2017. The China human capital report 2017 was released. Human capital calculation for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) were extended to 1985-2015. There were some revisions and improvements in the 2017 Report, including updated population of 2015 for some provinces based on new information, adding CHIP 2013 and CFPS 2014 data in estimating the Mincer equations, and adjusting the method in imputing the coefficients for the experience variable in the Mincer equations. The China Human Capital Report 2017 also improved with a unified imputation method for 1982 and 1987 census data using new information.

#### *Participants*

Belton M. Fleisher (Professor, Ohio State University & Special-term Professor, CHLR & Editor, China Economic Review) chaired the plenary session. The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology), Barbara Fraumeni (Professor, University of Southern Maine & CHLR, one of the founders of the Jorgenson-Fraumeni method of human capital calculation) and Carsten A Holz (Professor, Hong Kong University of Science and Technology & CHLR). Specially invited discussants and commentators, Junjie Hong (Dean, Professor, and Ph.D. advisor of School of International Economic and Trade in University of International Business and Economics), Weiguo Yang (Dean, Professor and PhD advisor of School of Labor and Human Resources, Renmin University of China) gave in-depth discussions on this year's Report.

We received 116 submissions, among which 37 papers were accepted for presentation in 9 parallel sessions, covering employment, education, labor market, cognition, health, income, and human capital.

### **2018--The Tenth International Symposium on Human Capital and Labor Markets**

#### *About the symposium*

The tenth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2018, organized by the CHLR was held in CUFU on

December 8-9, 2018. The China Human Capital Report 2018 was released. Human capital calculations for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) were extended to 1985-2016. There revisions and improvements in the 2018 Report included updated 2015 1% Demographic Sampling Survey data for 20 provinces, adding adult education enrollment into the total enrollment, adding new survey data CFPS 2016 in estimating the Mincer equations, and improving sample selection of the CHNS survey data. The China Human Capital Report 2018 also updated the national employment rate data of 2015 and updated that data for Taiwan from 1985 to 2016.

#### *Participants*

The new human capital report was presented by Haizheng Li (Professor, Georgia Institute of Technology), and Barbara Fraumeni (Professor Emerita, University of Southern Maine & CHLR, one of the founders of the Jorgenson- Fraumeni method of human capital calculation). Dale Jorgenson (Professor Emeritus, Harvard University, one of the founders of Jorgenson- Fraumeni method of human capital calculation) released a video speech reviewing the first participation in the human capital conference; he sent sincere wishes to the human capital project. Guoqiang Long (Deputy director of the Development Research Center of the State Council), Andrew Sharpe (Executive director of the International Income and Wealth Research Association), and Shi Jianping (vice president of the Central University of Finance and Economics) also attended the conference. Zhuo (Adam) Chen (Associate Professor, University of Georgia; Li Dak Sum Chair Professor in Health Economics and Co-Director, Centre for Health Economics, University of Nottingham Ningbo China) and Gordon Liu, (PhD., MOH Yangtze River Scholar in Economics, PKU BOYA Professor) presented their discussions of the human capital report. Benjamin F. Jones (Gordon and Llura Gund Family Professor of Entrepreneurship, Professor of Strategy, and the faculty director of the Kellogg Innovation and Entrepreneurship Initiative) presented a keynote speech.

We received 145 submissions, among which 52 papers were accepted for presentation in 13 parallel sessions that covered issues in health, education, cognitive skills, measurement of human capital, income, employment, productivity, migration and aging and household behavior.

### **2019--The Eleventh International Symposium on Human Capital and Labor Markets**

#### *About the symposium*

The Eleventh International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2019, organized by the CHLR was held in CUFU on December 13-14, 2019. The China Human Capital Report 2019 was released. Human capital calculations for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) were extended to 1985-2017. There revisions and improvements in the 2019 Report included updated 2015 1% Demographic Sampling Survey data, adding general secondary professional education data and adult secondary professional education data into the high school enrollment, calculating labor-force human capital by including or not including students, revising the method for calculating enrollment age distribution from 6 age groups to 3 age groups, adding new survey data CLDS 2014 in estimating the Mincer equations, and updating the CHNS 2015 and CFPS 2016 survey data. The center will cooperate with Jinan Human Capital Industry Research Institute to conduct human capital pricing research.

The Twelfth International Symposium on Human Capital and Labor Markets celebrating release of the China Human Capital Report 2020, organized by the CHLR was held in CUF on December 4-5, 2020. The China Human Capital Report 2020 was released. Human capital calculations for all provinces, autonomous regions, municipalities and special administrative regions (excluding Macao) were extended to 1985-2018. There revisions and improvements in the 2020 Report included updated human capital calculations for all provinces especially for the areas of Hong Kong and Taiwan. It also updated the physical capital on the national and provincial level.

## 历年人力资本发布会议回顾

### 一、第一届人力资本研讨会

#### 1. 会议内容

2009年10月10日，中央财经大学人力资本与劳动经济研究中心举办了主题为“人力资本的度量及其对增长和福利的贡献”国际研讨会，首次发布中国国家层面人力资本指数及《中国人力资本报告 2009》（中英文版）。项目负责人李海峥教授详细阐述了中国人力资本度量方法与相应的计算结果，以及中国人力资本度量项目的未来发展方向。

本项目探索性地建立了中国人力资本的综合度量体系，其阶段性成果包括：1985-2007年中国分城乡、分性别的名义与实际人力资本存量，相应人均人力资本与各种人力资本指数；人力资本分布状况和变化趋势；对2008-2020年中国人力资本水平的预测。

本次会议还组织了学术分会，分会主题包括人力资本度量方法、中国人力资本指数的构建、以及人力资本对经济增长和福利的贡献等。

#### 2. 出席嘉宾

2010年10月15日，中央财经大学人力资本与劳动经济研究中心举办了“第二届中国人力资本指数发布暨人力资本研讨会”，本次会议发布了《中国人力资本报告 2010》，内容包括：更新后的中国国家层面人力资本计算结果，并首次将中国人力资本的计算深入到省级层面，计算1985-2009年北京、甘肃、广东、江苏、辽宁五个省（市）的人力资本存量与指数。

### 三、第三届人力资本研讨会

#### 1. 会议内容

2011 年 10 月 28 日，中央财经大学人力资本与劳动经济研究中心组织召开了“第三届人力资本国际研讨会暨 2011 年中国人力资本报告发布会”，发布 2011 年中国人力资本指数和报告。与前两年的人力资本报告相比，《中国人力资本报告 2011》大幅度改进了计算方法以弥补省级数据的缺失，同时增加了微观调查数据，更新了 1985-2009 年国家层面人力资本指数并将省级层面估算扩展到 12 个省份：包括北京、甘肃、广东、江苏、辽宁、上海、安徽、山东、贵州、湖北、湖南和河南，并对各省人力资本分布和动态发展情况做出分析。

#### 2. 出席嘉宾

人力资本终生收入法的创始人之一 Barbara Fraumeni 教授、世界银行驻华主任经济学家 Philip O’Keefe 博士、欧洲人力资本项目负责人 Peer Ederer 教授出席，北京师范大学经济与工商管理学院院长赖德胜教授、中国社会科学院人口与劳动经济研究所都阳教授、武汉工程大学管理学院桂昭明教授应邀作为点评专家，围绕本年度人力资本报告进行了深入讨论。国家外国专家局科教文卫司副司长雷风云、国家自然科学基金委员会管理科学部主任李一军、中央财经大学副校长李俊生等以及其他国内外专家学者前来参会。

### 四、第四届人力资本研讨会

#### 1. 会议内容

2012 年 12 月 14 日，中央财经大学人力资本与劳动经济研究中心举行“第四届人力资本国际研讨会暨 2012 年中国人力资本报告发布会”，发布《中国人力资本报告 2012》。与 2011 年中国人力资本报告相比，2012 年中国人力资本报告使用了更新后的省级宏观数据，增加了天津、黑龙江、浙江、广西壮族自治区和陕西 5 个省（自治区、直辖市）1985-2009 年的省级层面人力资本的估算，完成了国家层面及 17 个省市的人力资本计算结果的更新，建立相应的人力资本综合度量体系及相应的面板数据。根据人力资本的计算结果，报告还初步分析了影响人力资本增长的因素、人力资本与退休年龄的关系、以及人力资本对经济增长的贡献等问题。同时，人力资本的各项度量指标数据开始通过中心的网站对外发布，促进学术资源的共享。

## 五、第五届人力资本研讨会

2013 年 12 月 15 日，中央财经大学人力资本与劳动经济研究中心举行“第五届人力资本国际研讨会暨 2013 年中国人力资本报告发布会”，发布《中国人力资本报告 2013》。与 2012 年中国人力资本报告相比，2013 年中国人力资本报告使用 2010 年人口普查数据，将全国和各省人力资本更新至 2010 年；新增加计算了海南、江西、吉林、四川和重庆人力资本，基本构建形成中国国家层面及二十二个省级层面人力资本面板数据库；估算并发布全国以及各省 1985-2010 年固定资本存量；计算并发布各省 1985-2010 年生活成本调整指数。会议展示了部分基于《报告》中数据进行研究的学术成果，并总结了《报告》五年内取得的成果。

### 2. 出席嘉宾

2014 年 10 月 31 日，中央财经大学人力资本与劳动经济研究中心举行“第六届人力资本国际研讨会暨 2014 年中国人力资本报告发布会”，发布《中国人力资本报告 2014》。与 2013 年中国人力资本报告相比，2014 年中国人力资本报告新增加计算了山西、青海、内蒙古、新疆、西藏、云南、福建、河北、宁夏九个省（自治区）和香港特别行政区、台湾省人力资本，重新计算海南省人力资本，基本构建形成中国国家层面及所有省、自治区、直辖市和特别行政区（澳门特别行政区除外）人力资本 1985-2010 面板数据库；估算并发布全国以及各省 1985-2010 年固定资本存量；计算并发布各省 1985-2010 年生活成本调整指数。

2015 年 12 月 12 日，中央财经大学人力资本与劳动经济研究中心举行“第七届人力资本国际研讨会暨 2015 年中国人力资本报告发布会”，发布《中国人力资本报告 2015》。与 2014 年中国人力资本报告相比，2015 年中国人力资本报告将所有省份、自治区、直辖市、特别行政区（澳门特别行政区除外）的人力资本计算扩展到 1985-2012 年。2015 年的报告在方法和数据上进行了调整和更新，比如统一了每年分城乡、性别的各级教育水平招生人数的数据来源并更新到 2012 年、在 Mincer 方程参数估计时添加了新的数据库中国家庭追踪调查 2011 年数据等等，基于估算的每年人口数据，增加了劳动力人口平均年龄、平均教育程度、高中及以上人口比重结果。研讨会还发布了成立中国个体复杂技能测评实验室的消息。

2016 年 12 月 10 日，中央财经大学人力资本与劳动经济研究中心举行“第八届人力资本国际研讨会暨 2016 年中国人力资本报告发布会”，发布《中国人力资本报告 2016》。与 2015 年中国人力资本报告相比，2016 年中国人力资本报告将所有省份、自治区、直辖市、特别行政区（澳门特别行政区除外）的人力资本计算扩展到 1985-2014 年。2015 年的报告在方法和数据上进行了调整和更新，比如基于新的数据来源更新了 1985-2014 年每年分城乡、性别的各级教育水平招生人数，统一了全国和省份的人口估算方法并重新计算了国家人力资本，估算了 1985-2014 年全国以及各省的固定资本存量。
